





The Hague Abduction Treaty is a useful civil remedy to obtain prompt return of a child to the child's habitual residence when abducted or retained out of that country. However, there are many cases where the Hague Treaty does not apply, where it is not useful, or where it is not the best remedy available for a certain case.
